We are committed to delivering sustainable projects that meet high environmental standards and incorporate sustainable design principles to enhance energy efficiency and occupant wellbeing. Furthermore, we commit to conducting our business in a manner that is fully responsible, demonstrably sustainable, and rigorously compliant with all applicable environmental legislation and regulatory requirements.

Our Commitment:

- We comply with all applicable environmental laws, regulations, standards and codes of practice.
- We source materials from and collaborate with suppliers, industry organisations, and clients who share our commitment to environmental responsibility, prioritising the use of sustainable low impact products where practicable, e.g. the use of low-carbon and energy-efficient options, working together to develop environmentally responsible solutions.
- We are dedicated to reducing energy consumption in our manufacturing and installation processes by using energyefficient equipment and practices.
- We regularly assess our energy usage and implement strategies to improve efficiency and reduce our carbon footprint (see Carbon Reduction Policy).
- We monitor and mitigate biodiversity and environmental risks at our manufacturing and installation sites.
- We monitor and optimise our water usage across all operations, implementing measures to reduce water consumption and promote the responsible use of this vital resource.
- We continually evaluate our processes to identify opportunities to reduce environmental impacts and emissions associated with our manufacturing, transportation and installation practices and explore the use of clean energy sources in our operations.

Implementation:

To achieve these objectives, Permasteelisa Group will:

- Continuously improve our environmental practices. This
 includes setting measurable environmental objectives,
 reviewing our progress, and ensuring the ongoing education
 and training of our team to enhance their environmental
 awareness and empower them to contribute to our
 environmental objectives.
- Maintain and continually improve our Environmental Management System (EMS) in accordance with ISO 14001 standards, ensuring it is effectively implemented across all levels of the organisation.
- Conduct regular environmental audits and assessments to monitor compliance and risk as well as identify opportunities for improvement.
- Deliver sustainable projects that meet high environmental standards and incorporate sustainable design principles to enhance energy efficiency and occupant wellbeing. For example, through the development and implementation of advanced innovative façade systems to improve building performance and reduce environmental impact.
- Work closely with our supply chain to ensure that environmental considerations are integrated into design, procurement and subcontracting processes.
- Implement effective waste management systems, ensuring that waste generated during manufacturing, installation, façade care and at end of life, is eliminated, minimised, reused, or recycled wherever possible to divert waste from landfill, e.g. through innovative recycling solutions and reducing packaging waste.
